Why writing seminars?

- "On one hand then, getting writing done is an essential component of scholarly life, and yet much research shows that it continues to be marginalized and squeezed out of the everyday practices of researchers and academics." (Aitchison & Guerin, 2014: 4)
- Mental health

- Others write
 - "The definition of a common purpose for the group, in terms of both writing and accountability, was a watershed moment that provided the impetus for the establishment of other practices commonly associated with team effectiveness. These included an informal, tacit negotiation of roles and responsibilities and a conscious commitment to continuous learning." (Wardale et al., 2015: 1308)
 - "[...] engagement of anyone's attention, motivation or desire is not usually attained without providing something of value in return, and in the case of doctoral writing groups, the value that keeps participants returning is a mixture of affordances: scholarly writing progress, social nourishment, resilience, enhancement of reflexive capacities and the simple pleasure of writing." (Fegan, 2016: 28)
 - "[...] writing retreats are effective not so much in terms of the cognitive dimension of writing but can best be explained by looking at the positive emotions they generate and their impact on the students' identities as writers. The retreats produced hard (numbers of words written) and 'soft outcomes' – social and emotional effects." (Papen & Thériault, 2018: 177-178)
