What is BMJ Impact Analytics?

BMJ Impact Analytics is the *only* impact tool focused on health and social care. It helps funders, academic institutions, and corporate organisations discover where their research has been cited in clinical guidance and health policies worldwide. It shows direct links to patient outcomes (decision support tools) and provides citations in context.



What makes it unique?

- **Specifically created for the medical research community** – The only tool in the market focused on health and social care.
- **Its focus on medicine helps provide more breadth and depth of content in the field:**
 - It's the **most up-to-date and comprehensive tool covering the greatest breadth of health policy and clinical guidance content**, BMJ has brought their health expertise to find and assess the best sources of health policy and clinical guidelines worldwide.
 - **Contextualises citations and shows further links between policy documents**, which provides even greater insight into how research is being used by policymakers worldwide.
 - **It shows the impact that is closest to the patient** – BMJ Impact Analytics tracks citations in local guidelines and BMJ Best Practice, which is ranked as one of the best clinical decision support tools for health professionals.
- **Big data techniques help advance how real-world impact is measured** – BMJ Impact Analytics tracks documents from 30,000+ global organisations in over 1,440 health-related sources and 175+ countries, classifying them into topics and subject areas and identifying and providing citations in context. This saves time for users as it allows them to easily see not only where their research has been cited but also how it's been cited.
- **Developed in collaboration with medical departments and funders** – Offering the impact data and features of the most value to this community.



How was it developed?

Research that improves patients' lives matters deeply to the funders, institutions and researchers who dedicate their resources to medical and health research.

As part of our vision for a healthier world, BMJ engaged with the medical and health research community about the evidence that demonstrates genuine real-world impact and how it can be discovered. In the course of this research, many research managers in health and medicine shared the related challenges that they face with information overload, time, and data quality.

It became apparent that AI and Machine Learning can help with finding and tracking vital evidence of real-world impact and also answering questions about research performance and strategies. **BMJ began collaborating with Overton to create a prototype that was tested extensively with funders, institutions and researchers.** This deep user research and engagement fed directly into the development of BMJ Impact Analytics.
