Anders Aschim (f. 1958) is Professor of Religious Education at Inland Norway University of Applied Sciences in Hamar. He graduated in Theology from MF Norwegian School of Theology, Religion and Society (1984) and holds a dr.philos. degree in History from UiT The Arctic University of Norway (2010). His main publications are in the fields of biblical studies and historical studies with a particular focus on Norwegian 19th century culture and religion.

Kaisa Häkkinen is Professor Emerita of Finnish at the University of Turku. Her areas of expertise are the history of Finnish and the Finno-Ugric languages, etymology and old literary Finnish.

Professor Dr. **Sabine Hiebsch** holds the *Kooiman-Boendermaker Chair for Luther Research and the History of (Dutch) Lutheranism* at Theological University Kampen, the Netherlands. She studied Catholic and Protestant theology in Paris, Tübingen, Amsterdam and Bonn. Hiebsch combines Luther research with the history of the Lutherans in the Low Countries, including the reception of Luther's theology, and the religious life in Lutheran congregations and their international connections. Peter Marshall is Professor of History at the University of Warwick, UK. He has published widely on the political and cultural impact of the British and European Reformations, and his books include *Beliefs and the Dead in Reformation England* (2002), *Mother Leakey and the Bishop: A Ghost Story* (2007), *The Reformation: A Very Short Introduction* (2009), and *Heretics and Believers: A History of the English Reformation* (2017).

Charlotte Methuen is Professor of Ecclesiastical History at the University of Glasgow. Her research interests include the Reformation, the history of women's ministry, and the history of the ecumenical movement, and she has published widely in all these areas. She has a particular interest in international aspects of the Protestant Reformation.

Endre Mørck is Professor of Norse philology at UiT - The Arctic University of Norway, where he has also served as Dean and Head of Department. His scholarship primarily focuses on Middle Norse diploma material and texts reflecting rural language from the older New Norwegian period, and he has explored the morphological and syntactic development from Old Norse to Modern Norwegian. He has also written about the modern standard and dialectal syntax. His most prominent works are the books

Gordon D. Raeburn obtained his PhD in Early Modern Scottish burial practices from the University of Durham in 2013, and from 2014 to 2017 he was a postdoctoral research fellow in the ARC Centre of Excellence for the History of Emotion at the University of Melbourne. In 2018 he was the inaugural John Emerson Research Fellow at the State Library of Victoria, Melbourne.

Kirsi Salonen is Professor of European and World History at the University of Turku. She is a specialist in the late medieval and Reformation period ecclesiastical history and of the Finnish Reformation.

Tanja Toropainen is a teacher in Finnish language at the University of Turku. She is a specialist in historical lexicology and old literary Finnish.

Born in Borgarnes, Iceland, in 1958, **Veturliði Óskarsson** studied linguistics and Icelandic language and literature at the University of Iceland 1981–1985, Nordic philology at the University of Copenhagen 1987–1991, and Nordic languages at the University of Uppsala 1997–2001. Between 1991 and 1997, he worked for the Icelandic Language Board. He received his doctorate in Uppsala in 2001. From 2003 until 2010, Óskarsson was employed at the University of Iceland, School of Education, Professor in Icelandic language from 2006. From 2010, he has been at the University of Uppsala, Sweden, where he has been Professor of Nordic languages since 2012. His main research interests are language contacts between Icelandic and other languages, as well as late medieval and early Icelandic language history and text philology. His latest work is an edition of the Old Icelandic *Slysa-Hróa saga*, published in 2019. Since 2010, he has been editor (from 2013 co-editor) of the peer reviewed journal *Scripta Islandica*. Veturliði Óskarsson is a member of Kungliga Humanistiska Vetenskaps-Samfundet in Uppsala, Agder Academy of Sciences and Letters, and Societas Scientiarum Islandica.

Liv Helene Willumsen is Professor Emerita at the Department of Archeology, History, Religious Studies and Theology at UiT the Arctic University of Norway. Her major field of expertise is seventeenth-century witchcraft trials in Scotland and Northern Norway, with a PhD in History from the University of Edinburgh (2008). Willumsen has written the exhibition texts at Steilneset Memorial in Finnmark, a Memorial for the victims of the Finnmark witchcraft trials. She also has a PhD in Literature from the University of Bergen, Norway (2003) on the Norwegian author Regine Normann (1867–1939). In addition, she has in the later years worked with early history of education. In 2019, Liv Helene Willumsen received the Norwegian King's Medal of Merit for her research.
